Florida Trip Personal Contract - April 18, 2018-April 23, 2018

We have set up the following pay plan for you. These dates reflect when we have to have the group payments in to the airline and to Festival Disney.

- * Thank you for your down payment of \$200 per person.
- * I understand another payment of \$250 per person is due by November 17, 2017.
- * I understand another payment of \$250 per person is due by December 15, 2017.
- * I understand another payment of \$250 per person is due by January 15, 2018.
- * I understand another payment of \$250 per person is due by February 15, 2018.
- * I understand that the balance (est. \$350 per person) of the trip payment per person is due by March 15, 2018.
- * I understand that by signing this contract that I am responsible for the agreed upon amount of the trip costs and that it is non-refundable, even if circumstances arise that prevent me from not participating in the trip after I have signed the contract. The Hampden Academy Music Association will honor the previous requests for financial assistance.
- * I understand that all checks are to be made payable to Hampden Academy Music Association or H.A.M.A.
- * I understand that each person (performer, chaperone, parent, guardian etc) traveling with the official music trip is to abide by the same payment deadlines and rules of the contract and is guaranteed by the parent/ guardian signing this contract.
- * I understand that as a performer with the above listed groups that, because of liability, I must remain with my group the entire trip. No side trips will be permitted during the official trip dates.
- * I understand that fundraising opportunities will be available through H.A.M.A. to offset the cost of the trip.
- * I understand that I can do fundraising on my own but will not be permitted to do so under the auspices of Hampden Academy or H.A.M.A.
- * I understand that if I decide to check my luggage and not use carry-on, I will be responsible for those baggage charges per the airlines standard charges at time of travel. If I am required to have a musical instrument for this trip, H.A.M.A. will cover the costs associated with getting those to Florida.
- * I will abide by all school and trip rules while on trip and these will be reviewed prior to the trip with students and parents/guardians. Serious infractions may result in being sent home at my parent's/guardian's expense and/or accepting any further disciplinary consequences given by Hampden Academy upon my return. Should the infraction involve any illegal activity, the police of the jurisdiction where the infraction is discovered will be notified and the parent(s)/guardian(s) of the student in question will be summoned to escort that student through the process. In other words, the musical directors must stay with their performing groups and any official chaperones will have paid for the trip and they are required to stay with the traveling group.
