Hampden Academy Music Association

CONSTITUTION

ARTICLE 1 - Name

The name of the organization shall be the Hampden Academy Music Association, otherwise referred to as H.A.M.A.

ARTICLE 2 - Purpose

Sec. 1 - To foster, support, and advance the cause of school music at Hampden Academy (H.A.)

Sec. 2 - To lend moral, physical, and financial support to the H.A. music program.

Sec. 3 - To encourage music within the school system, RSU # 22 and surrounding communities by widening the exposure of students and individuals to music - related opportunities and events.

Sec. 4 - To cooperate with the H.A. Music Department, faculty and administrators to promote the cause of music.

ARTICLE 3 - Membership

Sec. 1 - Membership shall not be limited, but open to include the parents/guardians of students involved in any phase or level of the music program, other interested individuals from the community, and all H.A. music students

ARTICLE 4 - Officers

Sec. 1 - The officers of this association shall be: President or Co-Presidents, Secretary, and Treasurer

BY-LAWS

ARTICLE 1 - Duties of the Officers

- Sec. 1 The President or Co-President shall preside at all meetings of the Executive Board and the annual meeting of the entire organization, shall appoint committee chairpersons, and shall be an ex-officio member of all the committees.
- Sec. 2 The Secretary shall keep records and minutes of all Executive Board meetings, to be submitted at monthly meetings and attend to all association correspondence.
- Sec. 3 The Treasurer shall keep an accurate record of all receipts and disbursements, and shall prepare a financial reports to be submitted at monthly and annual meetings.

ARTICLE 2 - Duties of the Executive Board

- Sec. 1 The Executive Board shall be comprised of the officers, H.A. music teachers and additional adult and student representatives of the four towns of RSU 22: Hampden, Newburgh, Winterport and Frankfort.
- Sec. 2 The Executive Board shall have the general supervision of all activities of H.A.M.A. and shall have the authority to raise and spend funds of the organization at such times and such methods as they deem necessary, by majority vote and within the fund-rasing guidelines established by the RSU 22 Board of Directors.

ARTICLE 3 - Meetings

- Sec. 1 The annual meeting of the H.A.M.A. shall be held in the fall of each school year.
- Sec. 2 Monthly meetings of the H.A.M.A. Executive Board shall be held on a regular basis during the school year.
- Sec. 3 The President may call any special meetings of the Executive Board.
- Sec. 4 A quorum shall consist of 60% of the Executive Board for a vote at any/all meetings.

ARTICLE 4 - Election of Officers

- Sec. 1 Prior to the annual meeting, a Nominating Committee of three shall propose a slate of officers for the coming year. The Nominating Committee shall consist of the Choral Director, Band Director and an acting member of the Executive Board. At the annual meeting, additional nominations from the floor will be heard, after the Nominating Committee has given its proposal.
- Sec. 2 Executive Officers, adult and student Board members will be nominated and elected at the annual meeting, for a term of one year, Executive Officers by a majority vote.
- Sec. 3 Persons may serve more than one, consecutive or not, in any office.
- Sec. 4. Persons may be removed from office by a majority vote of the Executive Board, due to proven breach of the H.A.M.A. Constitution and By-Laws.

ARTICLE 5 - Amendments

Sec. 1 - Amendments to the Constitution and/or By-Laws must be presented in writing prior to the vote of the Executive Board; presented in writing to the H.A. Principal for consideration and presented and posted prior to the vote of the membership at the annual meeting.
